## 7. HOME NURSING TRAINING FOR PATIENT CARE:-

It is submitted that Home Nursing Training is being imparted in all Districts of Haryana by the District St. John Centres. As it is well known that patients admitted in hospitals require the services of trained nurses. There are many other patients suffering from chronic ailments, who require the services of attendants at home.

The main aim of this project is to provide the patient care assistance to sick persons/bed ridden at their homes. This service helps the sick and helpless old people and in turn also provide employment to the unemployed vouths.

In this project candidates (male/female) who have attained the age of 18 & above are registered and are imparted Home Nursing training with the basic First Aid. The trained candidates are given the opportunity to provide the patient care services in the homes/hospitals The fixed remuneration may be given to the attendants by the patients. Home Nursing also been included training has in the Antodya "Mukhyamantri **Parivar** Utthan Yojana". The duration of the training is 4 days (24 Hrs) as per guidelines issued by the St. John Ambulance (India), National Headquarters, New
